

Tobacco Hazards Regulation of National Changhua University of Education

Approved at Student Affairs Meeting on Jan.15, 2015

1. The Regulation was formulated by National Changhua University of Education (hereinafter referred to as the University) for our students to foster virtues of law-abiding and respect to others as well as to build a smoke-free campus.
2. The Regulation is applied to students of the University.
3. All faculty of the University is obliged to dissuade our students from smoking in the campus or report any violation to Guidance and Counseling Section of Office of Student Affairs. The identity of the reporter is kept strictly confidential.
4. The measures taken under Tobacco Hazards Regulation:
 - 4.1 The students who violate against the regulation of no-smoking of the University shall receive quit-smoking education at Health Center and be filed and followed up after finishing the program. Those who fail to finish the program will be penalized by ONE reprimand.
 - 4.2 The students who violate against the regulation of no-smoking of the University for the second time shall receive quit-smoking education at Health Center and be filed and followed up after finishing the program. Those who fail to finish the program will be penalized by TWO reprimands.
 - 4.3 The students who violate against the regulation of no-smoking of the University over three times shall be penalized by ONE minor demerit.
 - 4.4 The students who violate against the regulation of no-smoking at dormitory shall be filed into the violation records of student dormitory other than receiving the penalties above.
 - 4.5 According to Article 31 of Tobacco Hazards Prevention Act, any violators in the campus reported by the authority, Changhua County Public Bureau, shall be fined by an amount of no less than NT\$ 2,000 but no more than NT\$ 10,000.
 - 4.6 Any students who actively involve themselves in the promotion and education of tobacco hazards prevention will be awarded based on the Regulations of Student Rewards & Punishments of the University.
5. The Regulation shall go into effect after being approved by Student Affairs Meeting and ratified by President. The same procedure shall be applied to the amendments likewise.

3. Once the violator is convicted by the authority, he or she shall receive quit-smoking education at Health Center based on the Guidelines on Tobacco Hazards Regulation.
